INTRODUCTION

City Index Limited (via the UpTick platform) ("us" or "we") will make available to you a trading account (the "Demo Account") for the purpose of demonstrating the features of our trading services and the derivative financial instruments and contracts that we offer (our "Markets").

Use of the Demo Account is subject to the following terms and conditions (the "Demo Account Terms"). By accessing the Demo Account, you agree to be bound by the Demo Account Terms.

OPERATION OF YOUR ACCOUNT

Operation of the Demo Account

1. We will open a Demo Account for you and allocate a credit to the Cash balance of your account. You may use the credit to place trades and to fund open positions in certain Markets that we make available in the Demo Account. This credit is not money and has no value. It may not be withdrawn or transferred to other accounts you hold with us or to third parties.
2. The Demo Account is provided solely for demonstration purposes and any trades you place in the Demo Account do not create any rights between us and you. In particular, you will not have any rights to realised profits, daily financing fees paid on short positions or any other credits to the Demo Account.
3. We will provide proprietary real-time market data to the Demo Account and all quotes, execution prices, and the valuations of open positions will be based on this market data.
4. We may make available from time-to-time news, charting tools and research to the Demo Account. This information is provided under license from third parties and we make no warranty as to accuracy and completeness of such information.
5. We do not warrant that any information or functionality provided through the Demo Account will be error free or accessible at all times. The Demo Account or any portions thereof may become inaccessible or inoperable at any time or from time-to-time.
6. The information, content and functionality provided in the Demo Account may be changed at any time and without notice. Changes may be made to the Demo Terms by updating this posting. We reserve the right to suspend or withdraw the Demo Account at any time.
7. Copyright in the information, content and functionality of the Demo Account is owned or licensed to us unless otherwise noted. You may imprint, copy, download or temporarily store extracts for your personal information. Any other use is prohibited unless you first get our written permission. In particular you may not use or reproduce any information, content and functionality on any other website or link it to any other website without our prior permission.
